A: Honorary Fellows approved by Council on 8 March 2024

Professor Mahendra Patel OBE PhD FRPharmS FHEA FIPA (India) FIIOPM

Professor Mahendra Patel is an international leader in the world of pharmacy. He is a founding member and head of the newly established Centre for Research Equity at the University of Oxford. Professor Patel's work has focused on health inequalities within marginalised and underserved communities, championing inclusiveness in research and treatments. Through his work representing the Royal Pharmaceutical Society and his senior pharmacy role Professor Patel has formed strong relationships with the RCGP, supporting its programmes and championing community care. Significantly, he played a key role in expanding the diversity of people taking part in the PRINCIPLE and PANORAMIC trials, two national priority COVID studies investigating treatments in a community setting. His work has changed the way research trials are now designed sets an exemplar for all study teams.

B: Honorary Fellows approved by Council on 22 June 2024

Professor Kevin Fenton CBE FFPH PhD

Professor Fenton is a Public Health Physician and Infectious Disease Epidemiologist. Professor Fenton is President, UK Faculty of Public Health; Chief Advisor on HIV, Department of Health and Social Care; Director, Office for Health Improvement and Disparities (London); Regional Public Health Director, NHS London; and Statutory Health Advisory to the Mayor of London. He holds Honorary Professorships with the University College London and London School of Hygiene and Tropical Medicine. Former roles include National Director for Health and Wellbeing at Public Health England (2012-2017) and Director of the United States National Center for HIV/AIDS, Viral Hepatitis, STD, and TB Prevention, part of the Center for Disease Control and Prevention (2005-2012).

Professor Navneet Kapur FRCPsych MD

Professor Kapur is Professor of Psychiatry and Population Health (University of Manchester) and Honorary Consultant Psychiatrist (Mersey Care NHS Foundation Trust). He is Director of the National Confidential Inquiry into Suicide and Safety in Mental Health; Head of Research at the Centre for Mental Health and Safety; and a member of the National Suicide Prevention Advisory Group (England) and helps to lead a major NHS England Quality Improvement Initiative focussed on suicide prevention. Professor Kapur has held a number of roles for NICE including chairing the development groups for the NICE self-harm guidelines and Quality Standards.

Professor Rebecca Malby

Professor Malby is an Honorary Visiting Professor at the University of York, as well as previously being a Professor in Healthcare Leadership at the University of York. She is also a Visiting Professor in Health Systems Innovation at the Universities of Huddersfield and London South Bank. She leads the national Universal Healthcare Network working on how the NHS can make sure services are fair for all; and is a national leader of Primary Care. She is an Independent Non-Executive Member for Future Generations at NHS West Yorkshire Integrated Care Board. She is known to be an energetic and enthusiastic leader of change and a forward thinker. She has made sustained and demonstrable impact through her work on the quality of health services with global reach. Becky is also an advisor to the Bromley by Bow Centre in London, and the external examiner at the Imperial Digital Academy, and a nominator for the Ashoka network.

Thea Stein

Thea Stein is the Chief Executive of the Nuffield Trust. She took up the post in September 2023. Thea was previously Chief Executive at Leeds Community Healthcare NHS Trust, and before then Chief Executive of Carers Trust, Yorkshire Forward and North East Leeds Primary Care Trust. Thea has also held a number of non-executive roles in housing organisations and academia. Thea was a trustee of the Nuffield Trust between 2019 and 2023.
