

RCGP East Scotland Faculty

Provost Medal

Aim:

To promote quality and excellence amongst GP peers by encouraging and recognising their outstanding achievements.

Award:

This award has been endowed by Dr Gordon McLeay, following his term of office as Provost (2021 - 2024).

The award will comprise a medal and will be presented at the RCGP East Scotland Faculty Annual Lecture in June.

Eligibility:

The nominee will normally be a member or fellow of the College in good standing, who has provided excellence/substantial contribution to General Practice in the East Scotland Faculty area and/or in a national or international context.

However, the nominee may be a non-member of the College that the Faculty would wish to recognise for their outstanding contribution to General Practice.

Process:

- 1. Nomination should be made by a Member or a Fellow of the College in good standing.
- 2. Nominations should be seconded by a Member or Fellow of the College in good standing.
- 3. Self-nomination is not appropriate for this award.
- 4. The award will be adjudicated by the Faculty Fellowship and Awards Committee of the East Scotland Faculty which will make recommendation to the East Scotland Faculty Board.
- 5. If no nominations of a sufficient standard are made, the Faculty Fellowship and Awards Committee may nominate a recipient or recipients.
- 6. Although there will normally be only one recipient annually, this does not preclude more than one award being made in any one year. If no suitable nomination is made, no award will be made that year.
- 7. The final decision on making the award will rest with the East Scotland Faculty Board.

- 9. The closing date for nominations: 31 January 2025.
